Chairman Gunnells stated for the record that both the Press and Banner and the Index Journal were notified of the meeting and that the meeting was posted on County Buildings as required by the Freedom of Information Act.

## **APPROVAL OF MINUTES:**

Councilman Thomas made a motion to approve the minutes of the January 9, 2006, regular county council meeting. Councilman Davis seconded the motion. The motion carried 6-0-0.

## **OLD BUSINESS:**

Councilman Norris made a motion to approve the resolution. Councilman Calhoun seconded the motion. The motion carried 6-0-0.
  - 2) A resolution (06-03) to void and replace Resolution 81-05, and authorize the County Director to enter into a contractual relationship with Branch

Banking and Trust Co. of South Carolina (BB&T) regarding a lease-finance agreement for the purchase of new hardware and software to update the Clerk of Courts office. Councilman Davis made a motion to approve the resolution. Councilman Norris seconded the motion. The motion carried 6-0-0.

- 3) A resolution (06-04) providing for the expenditure of accounts payable from the Infrastructure Development Fund for taxes, tag and title for the recently purchased Assessor's vehicle. Councilman Davis made a motion to approve the resolution. Councilman Norris seconded the motion. The motion carried 6-0-0.
- 4) A resolution (06-05) to authorize the expenditure of Accommodation Tax monies as recommended by the Accommodation Tax Committee. Councilman Thomas made a motion to approve the resolution. Vice Chairman Simpson seconded the motion. The motion carried 6-0-0.
- 5) A resolution (06-06) providing for the expenditure of Title III Funds for FY 04-05. Councilman Thomas made a motion to approve the resolution. Councilman Norris seconded the motion. The motion carried 6-0-0.
