MINUTES**

**PRESENT:** Chairman Gunnells, Councilman Simpson, Councilman Davis, Councilman Thomas, and Councilman Norris.

**ABSENT:** Councilman Calhoun

**CALL TO ORDER:**

Chairman Gunnells called the meeting to order at 7:30 p.m.

**PLEDGE OF ALLEGIANCE:**

Chairman Gunnells led the audience in the Pledge of Allegiance.

**INVOCATION:**

Councilman Thomas gave the invocation.

**FREEDOM OF INFORMATION ACT:**

Chairman Gunnells stated for the record that both the Press and Banner and the Index Journal were notified of the meeting and that the meeting agenda was posted on County Buildings as required by the Freedom of Information Act.

**APPROVAL OF MINUTES:**

- a) Councilman Thomas made a motion to approve the minutes of the November 28, 2005 county council meeting. Councilman Simpson seconded the motion. The motion carried 5-0-0.
- b) Councilman Thomas made a motion to approve the minutes of the December 5, 2005 special county council meeting. Councilman Simpson seconded the motion. The motion carried 5-0-0.
- c) Councilman Thomas made a motion to approve the minutes of the December 7, 2005 special county council meeting. Councilman Simpson seconded the motion. The motion carried 4-0-1 with Councilman Davis abstaining.

Councilman Calhoun arrived for the meeting.

**PRESENTATIONS:**

Mr. Brad Cuttill, City of Abbeville Recreation Department requested a contribution from County Council of \$6,000.00 to defray costs of resurfacing the Pete Smith Tennis Courts. Chairman Gunnells stated that Council would take this under consideration and let him know when a decision was reached.

**NEW BUSINESS:**

Councilman Norris made a motion to add items #4 thru #7. Councilman Davis seconded the motion. The motion carried 6-0-0.

a) First Readings: New Policy – All first readings are read into the record by the Chairman, and a vote is not necessary.

b) Resolutions:

- 1) A resolution (84-05) to authorize the transfer of \$29,653.25 from the Local Option Sales Tax Account to the General Fund. Councilman Davis made a motion to approve this resolution. Councilman Thomas seconded the motion. The motion carried 6-0-0.
- 2) A resolution (85-05) to authorize the transfer of \$16,276.76 from the Local Option Sales Tax Account to the General Fund. Councilman Norris made a motion to approve this resolution. Councilman Simpson seconded the motion. The motion carried 6-0-0.
- 3) A resolution (86-05) acknowledging and recognizing The Honorable David (Tojo) Forrester for his dedicated years of service to the residents of Abbeville County. Councilman Simpson made a motion to approve this resolution. Councilman Davis seconded the motion. The motion carried 6-0-0.
- 4) A resolution (87-05) to authorize the County Director to purchase a copier, fax, printer combination unit from SCM Office Supply not to exceed \$7,280.00. Councilman Davis made a motion to approve this resolution. Councilman Norris seconded the motion. The motion carried 6-0-0.
- 5) A resolution (88-05) authorizing the payment of a Christmas bonus to all Abbeville County employees for year ending December, 2005. Councilman Norris made a motion to approve the resolution. Councilman Davis seconded the motion. The motion carried 6-0-0.

- 6) A resolution (89-05) authorizing the County Director to enter into agreements to purchase materials and services needed to further the construction of the Farmer's Market. Councilman Simpson made a motion to approve the resolution. Councilman Davis seconded the motion. The motion carried 6-0-0.
- 7) A resolution (90-05) providing for the expenditure of accounts payable from the Infrastructure Development Fund for a vehicle for the Assessor's office. Councilman Thomas made a motion to approve the resolution. Councilman Norris seconded the motion. The motion carried 6-0-0.

#### **DIRECTOR'S REPORT:**

Interim County Director Larry Walker spoke to council about the Department of Corrections findings on the County Prison condition and that they were preparing a cost estimate to bring the prison into compliance with their D.O.C. requirements.
